	<p>BURS has developed a new income tax company form, guide and annexure (new income tax company return SAT ITA 22) having considered the 2011 tax amendments published in the Government Gazette.</p> <p>Some information in Part A (basic details) and Part F (quarterly payments) in the return will be pre-printed prior to use. The new returns being issued to clients are for the tax year June 2012 and a blanket extension has been granted to taxpayers according to their financial year ends.</p>
